## SECTION 4: First aid measures

### 4.1. Description of first aid measures

- First-aid measures after inhalation : If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical advice/attention if you feel unwell.

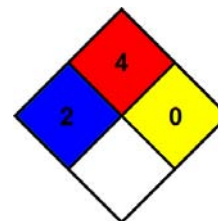
